# 20 Years Of Pension Reform: **The Good, Bad And Ugly**

The Contributory Pension Scheme (CPS) in Nigeria was established in June 2004 by former President Olusegun Obasanjo's administration. The enabling act was the Pension Reform Act (PRA) 2004, which was repealed and re- enacted in July 2014.

CPS represents a fundamental shift from the previous Defined Benefit Scheme (DBS), to a more sustainable and efficient defined contribution system.

The CPS was introduced to address the challenges of the DBS, which brought hardship to retirees because it was associated with non-contributory, largely unfunded, poor coverage, transparency, and inability to pay retirement benefits.

Before the CPS, the Federal and State Governments were unable to meet their pension obligations to their retirees because funds were not set aside to meet the retirement obligations of the retirees.

The situation led to the accumulation of substantial pension liabilities.

In the private sector, retirement plans before the CPS were characterised by low or no pension contributory commitment by employers.

Under the defined benefits scheme, retirement benefits are predetermined based on factors such as years of service and final salary.

In contrast, the CPS requires employees and employers to make

regular contributions to an individual

Retirement Savings Accounts(RSAs).

A retiree under the CPS is entitled to what he is able to save from his monthly stipends into the RSA with the Pension Fund Administrators while in active service, as well as accrued rights were applicable.

The Act became necessary to ensure that uniform regulations and standards apply to the administration of retirement benefits for the private and public sectors, as well as to ensure that individuals save towards catering for their old age.

Currently, the CPS is regulated by the National Pension Commission (Pen-Com) and administered by 22 licensed Pension Fund Administrators (PFAs) and four Pension Fund Custodians(P-FCs) responsible for keeping safe custody



of pension assets on trust on behalf of the contributors.

One of the significant advantages of the CPS in Nigeria is its stringent regulation and oversight.

PenCom serves as the regulatory authority, enforcing compliance and safeguarding the interests of pension contributors.

The Contributory Pension Scheme in Nigeria is a groundbreaking initiative that has revolutionised the nation's pension system.

The scheme offers employees a reliable financial safety net, addressing the longstanding issue of inadequate funds to pay retirement benefits to retirees.

The funds accumulated under the CPS are invested by the PFAs on behalf of the employees.

Meanwhile, data from PenCom reveals that Nigeria's pension fund assets rose to N19.531 trillion as at 31st January 2024.

This represents an increase of about 6.40 percent when compared to the N18.356 trillion that was reported as net asset value in December 2023.

These investments generate returns

over time, boosting the overall value of the pension fund.

The funds are invested in various financial instruments, such as stocks, bonds, and real estate, ensuring diversification and potentially higher returns.

Specifically, the CPS not only focuses on retirement benefits, but protects employees and their families in the unfortunate event of death or disability.

Under the scheme, the accumulated pension fund is paid out as death benefits to the legal beneficiaries of the deceased employee.

Similarly, the CPS provides immediate access to retirement benefits if an employee becomes incapacitated.

These provisions offer financial security and support for employees and their loved ones during difficult times.

The CPS offers a high level of portability and flexibility for employees, regardless of job changes or relocation within Nigeria, an employee's accumulated pension funds remain in the employee's Retirement Savings Account (RSA).

This flexibility enables individuals to maintain their pension contributions seamlessly and reduces administrative complexities. It also ensures that employees can benefit from the scheme consistently, regardless of their employment history.

The CPS cushions the effects of possible job loss, as the risk of job loss is a reality for workers.

"As an RSA holder, an employee can access 25% of their RSA balance to help cushion the effect of an unforeseen job loss if they cannot secure another job after four months.

It is essential to note that this partial withdrawal is not a replacement for retirement benefits but rather a means to offer immediate support during a difficult period.

The remaining balance in the RSA continues to grow and accumulate until the RSA holder attains retirement age.

Under the CPS, RSA holders can also use a portion of their retirement savings as equity contributions for residential mortgages.

This is part of PenCom's ongoing efforts to provide greater flexibility and access to pension funds for the benefit of RSA holders.

The commission recognises that many workers face challenges in securing adequate housing upon retirement and aims to address this issue by unlocking the value of their pension savings to facilitate homeownership.

RSA holders who have contributed to their accounts for at least five years and meet specific eligibility criteria can use up to 25% of their pension savings as equity contributions towards acquiring residential properties.

This policy aligns with PenCom's commitment to ensuring that pension funds catalyse economic development and social well-being.

In addition, the CPS aims to secure the financial future of workers, ensuring they can retire with dignity and peace of mind.

One of the primary objectives of the Contributory Pension Scheme in Nigeria is to promote a culture of savings among workers.

Under this scheme, both employees and employers make contributions to the pension fund, fostering a habit of disciplined saving for retirement.

This encourages financial responsibility and helps individuals build a substantial retirement corpus.

The Contributory Pension Scheme in Nigeria operates on a structured framework with clear guidelines for pension fund management by the PFAs.

This oversight mechanism ensures transparency and accountability in the management of retirement funds. Its introduction has instilled confidence among retirees, knowing that their pension funds are secure and subject to efficient management.

This has led to increased trust in the pension system, reducing the incidence of pension fraud and mismanagement that was prevalent under the old scheme.

The Contributory Pension Scheme in Nigeria also benefits the economy by channeling pension funds into various investment opportunities. These investments contribute to economic growth and development, creating job opportunities and stimulating entrepreneurship. As the pension assets grow, they become a vital source of long-term capital for the nation's development projects. With its portability feature, the CPS allows workers to switch employers without losing their accumulated pension benefits. This mobility fosters labor market flexibility and encourages job mobility, ultimately leading to a more dynamic and adaptable workforce.

However, having recorded remarkable successes and achievements in the last 20 years, the CPS is not without its share of accompanied challenges, complaints and criticism.

There are concerns about the adequacy of pension benefits and the need to continually review the contribution rates to ensure that retirees can maintain their desired standard of living.

Some workers and retirees under the CPS have continued to lament that the 25% of the total RSA contributed by a worker during his/her service years paid at retirement as lump sum is too small.

They also complained that the monthly stipends paid as pension is too low, while pensioners under the CPS are lacking in many other benefits.

The aggrieved workers, however, want the Federal Government to make budgetary allocations to cater to their pension needs, in addition to other benefits that are not available under the CPS.

As a result of some of the agitations, former President, General Muhammadu Buhari in May 2023, assented to the National Assembly Service Pensions Board bill which exempted the National Assembly workers from the CPS.

The assent, which industry operators say did not pass through due process, was done barely 24 hours before the end of Buhari's administration in May 2023.

After it became law, Senator Babajide Omoworare said in a statement that the new development was in furtherance of the provisions of Section 58 of the Constitution and the Acts Authentication Act Cap. A2, Laws of the Federation of Nigeria 2004.

Omoworare said: "The National Assembly Service Pensions Board (Establishment) Act establishes the National Assembly Service Pensions Board to administer the pension scheme for personnel of the Service and exempts the personnel of the National Assembly Service from the CPS.

While this new law has not gone down



well with the industry operators, the beneficiaries have often time complained of their displeasure in the CPS.

Similarly, a bill before the National Assembly which has passed the second reading also seeks to exempt the Police and other Paramilitary organisations from the CPS.

Senate President Godswill Akpabio has assured the Nigerian Police retirees that the Senate was willing and ready to pass the Police Pension Bill into law on time and transmit same to President Bola Tinubu for assent.

If the Bill is eventually passed into law, the police retirees will be exited from the CPS for an independent pension board.

However, Pension industry experts have stated that with the consistency in government's fiscal deficit, rising debt profile and dwindling revenue, it will be difficult, if not impossible, for the government to finance the new jumbo package.

According to the experts, such development will lead to situations where workers will retire and be unable to get any pension benefit.

Commenting on the performance of the CPS in the last 20 years, former President Olusegun Obasanjo in an interview said that the scheme which commenced about two decades ago is now providing the needed solutions to the country's huge pension challenges.

Obasanjo, also expressed joy at the growth of the pension assets over the last 20 years.

He explained that when his administration instituted the pension reforms and pushed for a bill to reform pension administration in Nigeria, there were no expectations that the assets will grow so rapidly and have the positive effect it has had so far.

In an interview with NAIPE Trumpet, Mr Michael Omisande, the Chairman, Nigeria Union of Pensioners, Contributory Pension Scheme Sector (NUPCPS) said that the CPS has eventually reformed the pension landscape within the last 20 years, as theold system, DBS, was not adequately funded and characterised with corruption and fraud.

In conclusion, to further improve the Contributory Pension Scheme in Nigeria, stakeholders have continually advocated for the incorporation of sustainable investment practices, including ethical and socially responsible investments.


Such measures would align pension fund management with environmental, social, and governance considerations.

# Insurance As Safety Net In The Face Of Rising Inflation

Reconomic conditions in Nigeria, over the last five years, have negatively impacted lives and businesses in the country.

No sector of the economy is spared this, not even the financial sector. This has also raised concerns about the effectiveness and usefulness of insurance in such periods of economic difficulties.

However, such concern ignores the crucial role insurance plays in loss prevention and reduction, especially during times of high inflation. At a time of such economic volatility, when unexpected losses have a larger financial sting than they ever have before, the safety net of insurance can be the difference-maker.

The result is an opportunity: for insurance companies to demonstrate their value by managing inflation risk and providing financial security and peace of mind to their customers.

Now, we are feeling the effects of an inflationary environment and periods of lower economic growth, illustrated most plainly by price shocks and the subsequent cost of living crisis. In such a landscape, insurers have a unique perspective and, indeed, responsibility in absorbing the impact for both consumers and the wider economy.

### Insurance, A Safety Net In Difficult Times

In plain language, the high cost of living and decreased purchasing power of individuals has an obvious consequence of a lower demand for insurance – especially in areas where customers view the expense as non-essential.

Global Head of Insurance, Wealth and Trend Research at Allianz, Arne Holzhausen commented, "Insurance industry, financial burdens can be smoothed and shared over time. While we cannot undo inflation for our customers, we can act as a buffer, cushioning the shock to an extent."

#### **Adapting To Customer Needs**

Chief Distribution & Regions Officer, Allianz UK, Nick Hobbs, said in the face of persistent inflationary pressures, the insurance industry has much work to do in remaining relevant and valuable to customers.

"A little more understanding of the things that keep our customers awake at night brings us all into better alignment as a profession, which can only be a good thing".

While insurers must take action to mitigate profitability and solvency challenges (only a profitable insurance company can offer reliable risk protection in the long run), it is essential that insurers

put customer needs at the forefront and avoid a purely commercial response to inflation. In other words, insurers have to think beyond higher priced premiums, stringent underwriting requirements and reduced risk appetite.

#### Actions Insurers Can Take To Respond To Inflation

There are a number of actions insurers can take to respond to the new macroeconomic environment and soften the blow to customers:

\* Product innovation: Insurers can offer products and solutions that address some of the macroeconomic risks customers are facing. For example, more affordable low-cost products with an increased focus on risk and loss prevention, as well as usage-based propositions. A good example of the latter is telematics technology.

\* Indexation: Incorporating an indexation feature in insurance policies ensures that the policy benefits keep up with the rising costs of living and inflation.

\* Review of indemnity periods: At times of shock, a small business might not fully understand how long it will take to return to full operations. Drawing customer attention to this and working together to set realistic indemnity periods is crucial.

\* Investment in technology and digitalization: Technology can help insurance companies automate various processes and streamline their operations, reducing costs and increasing efficiency. For example, online marketing and distribution, digital customer self-service, and claims automation.

\* Communication with customers: Educating customers on the potential impact of inflation on their coverage and the risks of underinsurance, as well as providing regular updates on any adjustments to products or pricing to account for inflation are key.

\* Strategic partnerships: Insurers can

combat inflation by partnering with other organizations, such as healthcare providers or technology companies, to develop new products and services that are more efficient and cost-effective.

\* Diversification of investments: Preventative asset allocation that invests in a range of different asset classes, such as equities, real estate and commodities can help insurers to spread their risk and generate returns that are not undermined by inflation. Insurers can also invest in inflation-linked bonds, building additional protection through investment returns that are directly linked to inflation.

This inflationary environment is hitting the insurance industry hard in supply chain constraints, labour shortages and increasing litigation costs. Insurers are accelerating their business transformation plans centered around three primary themes to mitigate these risks: data, technology and talent.

Risk mitigation starts with data. Insur-

ers use several methods to collect and analyze substantial amounts of information, such as process mining, statistical modeling and ¬-forecasting, and applying machine learning and algorithms. Data-driven insights help assess the capacity and performance of an insurer's network of suppliers and vendors, improve their ability to assess risk more accurately, optimize productivity and control costs.

Insurance is a heavy task- and transaction-based industry, and much of these tasks are still done manually. The mass exodus of skilled workers and unexpected retirements can pose workers compensation-related risks. To counter future supply chain disruptions and social inflation, insurers are accelerating their digital transformation strategies, including expansion of their vendor networks and partnerships, application of intelligent workflows and automation of underwriting tasks. Companies need to exploit technology to operate more efficiently and accurately assess risks.

Much like other industries are navigating the labour shortage, many insurers are paying higher wages, offering increased benefits and more work flexibility. Staying competitive in this environment requires sophisticated talent acquisition and retention strategies that go well beyond wage considerations. Companies need discipline and consistency in creating clearly defined and achievable career pathways through mentoring, upskilling and training to address skill and knowledge gaps.

#### Conclusion

The multifaceted effects of inflation on the insurance sector will continue to be an issue that companies need to navigate. Still, those that think strategically about how to use data and technology to boost efficiency and more holistically cultivate talent will likely be the most formidable competition.

# **Olorundare Sunday Thomas:** The Man Who Elevated Insurance Sector

hen Mr. Olorundare Sunday Thomas was appointed substantive Commissioner for Insurance/Chief Executive Officer of the National Insurance Commission (NA-ICOM) by former President Muhammadu Buhari, on 3rd of May 2020, stakeholders in the insurance sector heaved a sigh of relief knowing the capacity and capability of the man that is taking charge of the insurance sector.

It is no news that the Nigerian insurance industry, prior to Thomas appointment, was plagued with diverse challenges such as low rating/poor recognition in the financial services sector and the economy, unprofessional practices by some operators, low insurance penetration, distrust, disrepute, weak regulatory oversight, etc.

However, Thomas came on board and brought numerous changes and initiatives that elevated the status of the insurance sector.

Following his appointment as the Commissioner, Thomas introduced strategic policies and plans driven to enhance market development, efficiency in With Thomas as Commissioner, the atmosphere in the industry became more accommodating and cordial. Insurance operators showed desire for consistent advancement because of a better working relationship and comprehension of the activities of NAI-COM. service delivery, protection of consumers as well as stakeholder confidence in the insurance business. Accordingly, the industry did not only see improved rating, but launched into new growth areas and level.

#### Thomas as Commissioner/Chief Executive of NAICOM

One of the greatest feats achieved by Thomas which none of his predecessors were not able to achieve is that he changed the nature of the insurance sector from one where the various arms are constantly antagonistic and at loggerheads with each other to one of mutual understanding and respect.

With Thomas as Commissioner, the atmosphere in the industry became more accommodating and cordial. Insurance operators showed desire for consistent advancement because of a better working relationship and comprehension of the activities of NAICOM. As a result, all arms of the industry worked in unison with same intent and purpose, to grow and develop the insurance sector.

Also, one of Thomas' key achievements as commissioner was his focus on digital transformation. Recognising the growing impact of technology on the

insurance landscape, he championed the development of digital platforms to streamline and simplify processes, making the documentation easier for consumers to access information and services. His digitisation drive not only increased efficiency within the industry but also empowered consumers with greater control over their insurance choices. Under Thomas, the Commission successfully completed its portal. The NAICOM Portal started nine years ago, but until Thomas came on board, nothing was happening. Today, the portal is already up and running.

As Commissioner for Insurance/ Chief Executive of NAICOM, Thomas continued the drive to increase insurance penetration and market development in the country.

He introduced the 2021-2023 Strategic Plan with five points agenda designed to entrench effective and efficient service delivery, ensure safe, sound and stable insurance sector, adequately protect policyholders, and public interest, improve trust and confidence in the insurance sector and encourage innovation and promote insurance market development.

Also, Thomas renewed engagement with the Nigerian Content Development and Monitoring Board (NCDMB) and a committee was set up to work on the guidelines to enforce the law in the Nigerian content Policy. All the leakages hitherto being experienced were blocked which led to an increase in the retention of oil and gas insurance business.

Thomas instigated the development of more actuarial analysts' capacity in the industry as the first step of having more qualified actuaries in the country.

Thomas expanded the operating field by licensing more underwriting

Thomas expanded the operating field by licensing more underwriting companies, two Takaful insurance companies in addition to the existing two.

companies, two Takaful insurance companies in addition to the existing two. Also, four micro-insurance companies were licensed and an additional two are on the verge of being licensed.

In an attempt to increase insurance penetration in the country as well as increase government participation in insurance business, NAICOM, under Thomas, consistently engaged state governments to draw them closer and bring the gospel of insurance to their door steps. In the course of his stewardship, many state governors visited the Commission. The Commission also paid series of courtesy visits and entered into partnerships with many Ministries, Departments and Agencies (MDAs) of government as part of measures to increase penetration and awareness.

On the enforcement of compulsory insurance, NAICOM under Thomas embarked on various engagement measures across the country. Aside from visiting state governments to solicit for their support, especially on the domestication of Insurance Laws, NAICOM also worked in collaboration with the Federal Road Safety Corps, Federal ministry of transportation, Federal Fire Service, among others.

It is in light of these achievements that the Service Compact with all Nigerians, (Servicom) awarded him Best Supportive CEO on SERVICOM with a Letter of Commendation for the award presented to him on December 30, 2022 during the 2022 End of Year meeting and awards ceremony in Abuja.

Sunday Thomas' era as the Commissioner for Insurance was characterised by regulatory innovation, digital transformation, and a commitment to inclusivity which had profound impact on the industry.

#### **Thomas Qualifications**

Before this appointment as Commissioner, Thomas was the Deputy Commissioner in charge of technical matters at the Commission between April 2017 and August 2019.

He served as Director-General of the Nigerian Insurers Association (NIA) between May 2010 and April 2017 and it is to his credit that the Association successfully developed and deployed the Nigeria Insurance Industry Database (NIID) platform.

# Plan To Scrap PTAD: In Whose Interest?

he Nigerian Government during the Federal Executive Council (FEC) meeting held Monday February 26, 2024, in Abuja, presided over by President Bola Tinubu, decided to scrap some agencies, commissions and parastatals and also agreed to merge, subsume and relocate some of the agencies, commissions and parastatals in order to reduce the cost of governance.

The Pension Transitional Arrangement Directorate (PTAD) is one of the agencies to be scrapped and functions transferred to the Federal Ministry of Finance.

Government said its action is in line with the implementation of the Steve Oronsaye Committee Report submitted in 2012 on Rationalization of Ministries, Departments and Agencies of government.

Since the announcement of the government's plans to scrap PTAD and transfer its functions to the ministry of finance, pension industry's stakeholders and the pensioners union have continued to react to the matter.

While some have outrightly condemned the federal government's decision, pointing out that scrapping PTAD will take the Nigerian pensioners back to the dark days before the enactment of Pension Reform Act in 2004, when many pensioners lost their lives while waiting endlessly for their pensions, others are calling on the government to tread with caution in the interest and the overall well-being of the pensioners.

Similarly, some aggrieved Union members are threatening to take the federal government to court if they go ahead to scrap PTAD.

Some industry analysts have expressed concerns, asking why government decided to scrap the Directorate established since 2013,, adding that the scrapping of PTAD amounts to waste of resources and counter productive considering tax payers money spent in the

establishment and running of the Directorate for more than 10 years.

They appealed to the government to give PTAD time to complete some of the ongoing programmes such the "I Am Alive" and "Back End Computation for Pensioners" which implementations are due to commence soon, adding that considering financial implications and government's huge investments in these project, scrapping PTAD now when it has not completed the mandate to which it was established amounts to waste of money and government resources.

They also drew government's attention to how billions of naira that were meant for the payment of pensions were embezzled by the former pension controllers and directors.

PTAD was established in August 2013 in compliance with the Pension Reform Act of 2004, which was repealed and re-enacted in 2014, with the mission to provide exceptional, transparent and technology-driven,

innovative and long-term pension services through a competent and dedicated work-force.

PTAD came on board when the Defined Benefit Scheme (DBS) administration under the old pension offices was facing overwhelming challenges.

Speaking during an interview with NAIPE Trumpet, the National Chairman of the Nigerian Union of Pensioners, Contributory Pension Scheme (NUPCPS), Comrade Sylvanus Nwaiwu, expressed concern on the issue, describing it as "very unfortunate" even as he blamed some Nigerians who are instrumental to the matter for their narrow-mindedness and for allowing themselves to be used.

He expressed regret why government should forget very easily the suffering that pensioners under DBS had to go through in the past before getting paid which led to the 2004 pension reform and the establishment of PTAD.

"I have even seen a pensioner under PTAD who is already celebrating the recommended scrapping of PTAD. To me, this is very unfortunate. The situation is even more pathetic where majority of the citizenry is easily brainwashed.

"Another cause of concern is that our political system is yet to imbibe the culture of continuity. Where continuity is key, we rather build upon existing structures than destroy them. There is also the factor of our being too forgetful. Have we forgotten the nightmares pensioners under the old pension scheme (DBS) had to go through to receive their pensions before the introduction of PTAD, how many of them died during the frequent deceitful verification exercises? Have we also forgotten the billions of naira that were embezzled by the former pension controllers and directors?

"A major challenge before us is that in Nigeria laws are easily made and easily changed not for the citizens but with some people in mind. Once, the instigators of reforms are no longer in position of power to enjoy the benefits, the reforms they earlier sponsored are quickly condemned and sooner than later expunged whether they are good or bad. However, I was happy when I heard the National Assembly call for caution and proper investigation before scrapping or merging of any of the agencies recommended by the executive arm of the government.

Speaking on the performance of PTAD, Comrade Nwaiwu said, "I am not under PTAD, I am under PenCom. There's there-



fore little I can deliver on the performance of PTAD in terms of carrying out its statutory responsibility. I believe only PenCom as the apex supervisor of the Nigeria pension industry, can judge the performance of PTAD. However, being a member of the National Executive Council (NEC) of the Nigeria Union of Pension (NUP) that includes the DBS retirees and the Countributory pension retirees Sector, I can say from the feelers during our meetings that PTAD has steadily carried out its statutory responsibilities optimally.

In his contributions, NUPCPS Chairman, Lagos State Sector, Comrade Michael Omisande, highlighted why PTAD was established and why government decided to scrap it, just as he called on the federal government not to shy away from it's responsibility of taking care of the retirees who had laboured to build the country.

According to him, PTAD is an Agency established by the Federal Government for prompt payment of pensioners under DBS and also for managing and directing the affairs of the DBS in order to make it efficient. But since the Federal Government decides to implement the Oransanye's report, in order to reduce some Government Agencies, that is the reason why it is being scrapped in order to cut the cost for Government expenditure and duplication of Government agencies.

"The foundation of failure of the new Pension Scheme in Lagos State started when the Retirees accrued benefit since 2007 were not credited into their Retirement Savings Account (RSA) like others in Private Sector. The template used in calculating the bond is poor as it cannot put food on our tables.

"Government as a matter of facts cannot and should not deny or withdraw their responsibilities to the senior citizens who had laboured to build the state with their sweat and blood.

"All over the world, senior citizens are cherished, respected and cared for throughout their lifetime. That is the reason why such countries are moving forward. We are the birds that laid the golden eggs, we appeal to the Federal Government, to let us enjoy the dividend of democracy as we all know that without yesterday, there cannot be today," Omisande stated.

Meanwhile, the Southwest chapter of the Nigeria Union of Pensioners (NUP) has condemned Federal Government's plan to unilaterally scrap PTAD without the approval of the National Assembly, and threatened legal action against the federal government.

The Union made its stance on the matter known in a communique released at the end of the meeting of state chairmen, secretaries and leaders of the union, held in Abeokuta, Ogun State.

The union insisted that scrapping of PTAD would amount to taking pensioners back to Egypt "where our pensions and gratuities will be at the whims and caprices of larcenous civil servants."

According to the body, the Oronsaye report did not recommend the scrapping of PTAD and urged the federal government to allow PTAD to continue to exist as an agency that oversees pension issues of all pensioners.

# Insurers And Steps To Address Unpaid Claims

The initiative by the National Insurance Commission (NAICOM) to ensure that insurers clear all outstanding claims in their books this year is eliciting positive reactions from stakeholders and public, writes **EBERE NWOJI**.

ndeed, the year 2023 marked a turning point in the history of insurance practice in Nigeria, as it witnessed a redefinition of insurance practice by operators in the area of claims payment and premium generation.

With regards to claims' payment, insurers last year through the influence of the regulator, the National Insurance Commission (NAICOM), resolved to clear all cases of outstanding claims in their books by inviting members of the insuring public to come up with requisite documents for settlement of any outstanding claim they have with any insurance firm.

The operators through the directive of NA-ICOM, put up public notices in newspapers inviting members of the insuring public who have one case of unpaid claims or the other to come with necessary documents to have the claims paid.

NAICOM mandated the operators through their umbrella body, the Nigerian Insurers Association (NIA) to do this while the commission carried out necessary supervision.



This is a paradigm shift from hitherto practice of claims repudiation by many insurance firms, a situation which has, over the years, portrayed the sector in bad light.

Members of insuring public hailed this initiative while stakeholders said it would surely boost the industry's image.

\*Place of claims payment in insurance value chain\* :

Claims payment in insurance contract serves as spice that attracts potential policyholders to insurance patronage.

Insurance claim in its simple definition is a formal request for compensation made by

a policyholder to an insurance company for loss (es) suffered under the terms/conditions of the policy. Although a claim could be filed by a third party like a lawyer or broker, only the person listed as beneficiary on the insurance policy is entitled to receive payment.

Ideally, insurance business is all about claims payment and claim is the main reason a policyholder takes up an insurance policy.

Without claims being paid by insurance companies, people are not likely to take up insurance policies. In every insurance contract, there is always a promise that when the

eventuality (risks) happens, the insurance company as a risk bearer, will be there to compensate the insured/policyholder.

Therefore, claims payment serves as a test instrument that determines the extent to which an insurance company lives up to the 'utmost good faith' promise. In other words, claim payment serves as brand image of an insurance company.

#### Claims payment situation in Nigeria:



Here in Nigeria, because some operators have over the years neglected claims payment, thereby making the insured to withdraw their patronage of insurance services, even the compulsory insurances.

This explains why among the compulsory insurance like the Third Party Motor or Marine insurance, you see people patronising quacks just to obtain any certificate to show to law enforcement agents and pass check points. This is because the prevailing cases of unpaid or delayed claims made the public not to value claims and prefer to obtain any paper bearing insurance from anybody instead of going to genuine operators to buy their insurance cover.

NAICOM as a regulator has made efforts to address the situation but none has yielded the desired result until the latest resolution to compel insurers to clear all outstanding claims in their books through invitation to the public to approach insurance firms owing them outstanding claims for payment.

## **Effects of claims repudiation:**

The effect of claims repudiation suffered by many insureds in Nigeria has affected the industry's image negatively.

Before Now, NAICOM had devised several ways of ensuring that insurance firms pay claims seamlessly.

Way back in the days of late Chief Oladipo Bailey as the insurance commissioner, the commission did a lot to improve claims payment in the industry.

One of the strategies he used was significant increase in the minimum capital of the industry from N20 million to N70 million for general insurers and N50 million for life insurers. This, he said, was to ensure that insurers have enough money in their coffers to pay claims. He also mandated for a re -registration exercise in the industry, a strategy he used to weed out non claims paying and weak insurance firms.

After this, he adopted the strategy of presiding over claims payment in the industry to the extent that he used his prerogative power to mandate the insurers to pay major claims that ordinarily they would not have agreed to pay.

A case in point was claims from the Ikeja cantonment explosion in 2002, which the late NAICOM Chief executive officer mandated insurers to pay under what he tagged "gentleman's agreement".

After him came Fola Daniel, who from his assumption of office in 2007, continued the crusade about the place of claims payment in insurance contract.

Daniel had told the insurers that the best advertisement they would do that could pull crowd to insurance firms is seamless claims payment.

The late Emmanuel Chukwulozie was also not left out among NAICOM chief executives who fought for claims payment. Even the former insurance commissioner, Alhaji Mohammed Kari, did not mince his words in telling the insurers the mandatory nature of claims payment in insurance contract.

The Immediate Past Commissioner, Mr. Sunday Thomas, seems to be a stronger force

compared to his predecessors in pushing for seamless claims payment in the industry.

Thomas had before now threatened to adopt the 'name and shame' strategy in getting insurance firms pay claims.

This, according to him, will involve publishing names of insurance firms that failed to pay claims for no genuine reason.

#### NAICOM's current efforts:

With the "10 year strategic road map" of NAICOM under the administration of the former commissioner, Mr Sunday Thomas, transformation of the regulatory environment to sustain the industry's growth topped the list.

Industry analysts interpreted the move by the commission to finally address cases of unsettled claims in the books of insurance firms as a major part of the transformation targeted at making Nigerians renew their interest and appetite for insurance.
